

Let's Talk Taxes . . .



It's not unusual for commercial property taxes to rise as local governments seek more money for schools, law enforcement, fire protection and other needs. But when you get your tax bill, take a close look. It may have increased too much. Check out these items:

Number transpositions - It's possible for assessors to make errors in the physical descriptions of properties. They might list the property as being 21,000 square feet when it is actually 12,000. Transposition of numbers is one of the more common mistakes when recording data.

Classification - The assessor might improperly classify your property into a category with a higher rate. Check into whether you are eligible for special rates or credits. Some jurisdictions apply total and partial exemptions and credits to property tax, based on how the property is being used. However, it is the owner's responsibility to apply for these. In other jurisdictions, there is a lower tax rate for vacant commercial and residential property.

Small Business Program Kicks Off in Brockton

On Tuesday November 9th, the Brockton 21st Century Corporation launched its Small Business Program with Mayor Linda M. Balzotti. The goal of the program will be to provide Brockton's small businesses with the necessary resources and technical assistance to foster both prosperity and sustainability. With limited resources, we procured for a consultant and that contract was awarded to OnPoint Coaching. John Lloyd, the company's principal, will serve in a part-time for approximately 10 months. John will have on-site office hours in our offices located at 50 School Street - second floor, from 8:30 a.m. to noon Tuesdays and Thursdays. This will provide the Corporation with about 40 hours a month with assistance to Brockton's small business. Ultimately, this program starts to address the need to reach out to our small business community.

In her opening remarks, Mayor Balzotti stated, "This program will help kick start Brockton's economic engine, providing assistance to small businesses not only helps those already here, but makes the city more attractive to business-owners looking to locate a business in the area."

Coming Soon:

Small business owners will receive assistance through monthly night time training sessions focused on addressing the challenges and opportunities small businesses face as well as providing solutions and guidance. An analysis of an existing small business database will be done, as well as a needs assessment of what resources Brockton's small businesses need. "Our goal with this program is to provide the appropriate support, resources, and direction to the small business in the community for growth and vitality," said Lloyd.

Chairman of the Board, Christopher Cooney weighed in on the importance of this program, "The Brockton small business program compliments the services that are currently being provided by the Small Business Assistance Center. SCORE and the SBA offer ongoing technical assistance and will further leverage the services of the B21st Small Business Program to address the needs of our business community"

In addition to this, John Lloyd will attend local, state, and federal meetings focusing on small business; and assist the Brockton 21st Century Corporation to establish monthly meetings with local, state, and federal

oration will hold free basic business workshops aimed at assisting potential and existing entrepreneurs. The workshops are co-sponsored by local banks and credit unions, the MA Small Business Development Center (SBDC), Metro South Chamber of Commerce, Brockton 21st Century Corporation and SCORE (Service Corporation of Retired Executives).

Session 1: "Learn the Fundamentals in Planning, Preparing For, and Financing Your Business" is geared toward helping potential entrepreneurs evaluate and understand the fundamentals of owning one's own business. Information on how to get started, where and how to get financing and the loan application process will be presented. Attendees will also be provided with

resources including: the Small Business Association; the Center for Entrepreneurship at Bridgewater State University; Massasoit Community College; Stonehill College, SEED Corporation, the Metro South Chamber of Commerce, SCORE, and more.

The Small Business Program will also identify, research, and apply for targeted grants to help enhance Brockton's existing small business resources. A welcome package for newly formed businesses will also be created and distributed.

The development of a micro-loan program for small businesses and a post-finance technical assistance program aimed at recently funded businesses in the Brockton area is also planned.

The Small Business Program will also review and update an existing Navigating Guide with input from relevant city departments. In the few weeks that Lloyd has been on board, accomplishments already include a revised business guide identifying resources for Brockton small businesses. This guide was translated by Jair Martins, a BSU grade student interning at Brockton 21st Century Corporation.




