# It's Time to Speak Up!

#### December 12, 2016 **Brockton City Hall**

Join us at Brockton City Hall in the Council Chambers on Monday, December 12th at 7:00 pm to prevent an increase in the Brockton Commercial Tax Rate. Let your concerns be heard!

Brockton is the hub of the Metro South Region (south of Boston). With an extensive infrastructure, ample workforce, and strategic location, it is an attractive city for businesses looking to grow and expand. Aside from these factors, among the most prominent indicators a business considers in choosing where to operate is the commercial tax rate. This is particularly true when comparing a nearby community or a similar sized "gateway city." When combining a lower commercial tax rate with lower water and sewer rates, Brockton can gain a significant strategic advantage in attracting and retaining business. In order to achieve growth, Brockton must provide value to business. Setting a more competitive rate is a clear sign that Brockton wants business!

The current commercial tax in Brockton is 32.03 for every \$1,000 of a property's assessed value (factor of 1.57). While it decreased over the past couple of years, Brockton still has the 4th highest commercial tax rate in the Metro South region and the 24th highest in the state. In recent years the Brockton City Council has begun to recognize the importance of attracting/retaining business in creating an economically viable community. Important to this strategy is setting an attractive commercial tax rate, thereby increasing the commercial tax base and alleviating the burden to residents. To ensure that Brockton moves forward, we need to encourage the City Council's favorable vote on December 12th.

During the program, Sue Joss reflected on the Chamber's recent accomplishments, including hosting over 70 programs, growing membership engagement, and recent studies, such as the 65-acre Brockton Fairgrounds study to determine its best and highest use as well as the 32 acre Brockton CSX Railyard study and a Regional Water Supply and Treatment Authority study.

The Chamber also conducted several community familiarization tours with the Massachusetts Office of Business Development in Brockton and the towns of Easton, West Bridgewater, and Avon. During the tours, over 20 businesses that help drive the local economy were highlighted. The Chamber assisted over 95 companies to expand and relocate within the region through consultation, referrals, marketing, and the Chamber's Regional Site Finder website. Multiple businesses accessed the Brockton Micro Loan program and the Business Assistance Center saw an influx of over 500 people. This activity and project investment totaled more than \$350 million dollars and the creation of over 980 jobs.

The Chamber testified at public hearings for lower commercial tax rates in Brockton and Avon, resulting in more attractive rates to help retain business and spur development.

Finally, The Chamber marketed the Metro South region as an attractive place to visit and do business, promoting the tagline generated through a regional branding process, "When Metro South is Home, Everything is Within Reach."
