Chamber Moving Forward on Regional Interests & Tax Rates

At Issue, Regional Economic Development, Rail Yards, Wastewater Facilities and Business Development

Chamber Chairman, Peter Neville, CEO of Concord Foods and Chamber President, Christopher Cooney led discussions with top Massachusetts leaders to move critical issues forward. Secretary Richard Davey, Transportation, heard concerns about making better use of the 30 acre CSX rail yard that lies dormant in the center of Brockton. The site is a tremendous regional asset that could provide greater access to rail transportation for goods handled by area businesses. The group also discussed, better maintenance, promotion and use of state highway route 24, the Main Street for the Metro South region.

Neville, Cooney, and Pat Ciaramella of Old Colony Planning Council met with Secretary Rick Sullivan, DEP, to open up access to the Brockton Advanced Water Reclamation Facility for the benefit of the entire region. The facility recently received a one hundred million dollar renovation and is better equipped to serve the region as a result. Representatives of Easton, Avon, West Bridgewater and Brockton attended the meeting. Abington, Whitman, East Bridgewater and Stoughton are also considered as potential interested parties. An emphasis on providing greater sewer capacity to businesses and industrial park areas was the focus of the meeting.

Cooney met with Secretary Greg Bialecki, Economic Development, to stress the importance of Brockton as a Gateway City. He specifically mentioned the rail yards, route 24, sewer capacity and water supply with an emphasis on regional thinking and action to improve the entire area. Secretary Bialecki was extremely helpful and has agreed to support regional thinking on improving these areas. Cooney serves on the Secretary's Small

Business Round Table Council where topics like these can be further pursued. The Chamber recently received a renewed state designation as one of a dozen Regional Economic Development Organizations. Along with the designation, financial resources have been received to engage leaders and execute plans beneficial to fostering business development and growth in the Metro South Region.

in 1863 and consists of the flagship campus in Amherst, along with campuses in Boston, Dartmouth, Lowell and Worcester.

President Caret, a native New Englander, assumes the presidency of the University of Massachusetts after completing highly successful presidencies at San Jose State University and Towson University. President Caret presided over periods of significant growth at both universities and gained national acclaim for eliminating racebased graduation disparities at Towson.

President Caret has authored many articles in business and professional publications in the fields of chemistry, chemical education and higher education. He co-authored four textbooks in the fields of organic chemistry and allied health chemistry. The Maryland Chapter of the American Chemical Society recognized President Caret's achievements by honoring him with the George L. Braude Award in 2005.

The University of Massachusetts is the largest university in New England, with an enrollment of more than 68,000 students and graduating more than 13,000 students a year. UMass research expenditures exceed \$500 million and the University has become a national leader in generating licensing income. UMass has spent \$2 billion on campus construction and renovation over the past decade and its economic impact on the Commonwealth of Massachusetts is estimated at nearly \$5 billion a year.

Also at this meeting, Economic Impact Awards will be presented to

businesses who have made a significant investment in the Metro South region over the past year. Those receiving the award include Cheer Pack North America, EquipNet, LoJack Corporation, The Mattress Maker of New England, Lombardo's, Hardy's Fine Food and Catering, the Holiday Inn Express, Market Basket in Brockton and West Bridgewater, Old Colony YMCA, West Elm Village (Mechanics Cooperative Bank), and the Governor Ames Community Park.

Board service awards will also be presented, as well as the Charles A. Fuller Award, presented to an individual whose leadership performance, personal example and good influence has done the most to advance the welfare of the Metro South Chamber of Commerce and the community.

These loans assisted in the creation of 495 new jobs and leveraged \$66 million in bank loans and private funds. Under SEED's small loan programs, 42 loans were made for a total of \$1.9 million. These loans ranged from \$9,000 to \$120,000, assisted in the creation 187 new jobs, and leveraged \$7 million in bank loans and private funds. Chamber Participates in Photo Mural Project



The Chamber is also testifying before city and town officials in favor of attractive commercial tax rates in communities that set a higher commercial tax rate than taxes on residential properties. Avon and Brockton businesses want to remind Selectmen and City Councilors of the jobs and added benefits businesses bring to a community. A strong business base provides added value to support city and town operations. Increasing Tax rates above \$30. per \$1,000. on businesses can cause them to look elsewhere. Half of the Metro South Communities offer a lower unified tax rate that can save businesses tens of thousands of dollars on their tax bill by moving a few miles to another town. The Chamber urges the approval of a tax rate that attracts businesses that provide jobs and revenue for the community. The Chamber advocates for a commercial tax rate under \$30. per \$1,000. in Avon and Brockton where both communities are just below that level now.


