BSC Science Center Boon for Region

The Massachusetts State Senate and House of Representatives

BRIDGEWATER last spring made STATE COLLEGE good on their promise to place new

emphasis on public higher education by restoring \$41 million of system-wide funding. This infusion of resources has already begun paying dividends in the form of smaller class sizes, additional course offerings, new faculty hiring and the stabilization of student charges.

This past summer, Governor Romney added to the emerging groundswell of support for public higher education by recommending \$400 million of the state's budget surplus be directed towards needed capital improvements at our institutions.

As leaders on Beacon Hill consider this historic bill, it is important that the citizens of Southeastern Massachusetts grasp all that would be gained locally by its passage. Included in the proposal is \$91.5 million for projects in the region, \$60 million of which has been earmarked for a new integrated science facility at Bridgewater State College.

When BSC's Conant Science Center opened in 1964, it was designed for a campus of 800 full-time students. In contrast, the new facility would serve a campus community of nearly 10,000 and be equipped with state-of-the-art laboratories and technology. Students and faculty would have access to experiences and research tools on par with their peers at any institution anywhere.

This building's construction would fundamentally change the way we study science and, equally important, impact our region.
While all at Bridgewater State
College are committed to improving the quality and expanding the scope of the student experience, the complementary mission is to harness the energy that arises naturally from this

pursuit and channel it back into the public we serve.

For too long, Southeastern
Massachusetts has lacked the
critical foothold it needs for
scientific advancement and
discovery. As a result, our urban
centers – Fall River, New Bedford,
Brockton, Taunton and Attleboro –
have struggled to attract high-tech
industries and transition to the new
economy.

Employment and income growth throughout Plymouth and Bristol counties have lagged behind the rest of the state and, increasingly, those who represent the best and brightest of the next generation are leaving the region and commonwealth at an alarming rate.

Equally disturbing is the dwindling supply of new K-12 science teachers as their demand across the region and state continues to rise. Add to this a recent report by the National Center for Education Information which predicts that 40 percent of all teachers working today will retire within five years and the challenge before us becomes even more daunting.

Building an appetite for science begins at an early age. Teachers in primary and secondary schools have the power to engender this appreciation, but will only do so if their own experiences have been rewarding, enriching and stimulating.

Construction of a new science facility at Bridgewater State College would be the most ambitious building project undertaken by a state college in Massachusetts. That state leaders have proposed such an investment in Southeastern Massachusetts is an indication that the region is poised to take huge leaps forward.

At a time of clamor for more attention to science education, and a moment in which innovation and the generation of knowledge have never been more inextricably linked to the state's competitive edge, Southeastern Massachusetts has the opportunity to do what it has so rarely done over the past century – lead our state into the future.







Lean Concepts: Change in Management and Hourly Workforce

Many companies are accelerating their productivity growth by implementing Lean concepts as a way to streamline their businesses and the ability to compete. Since Lean, by definition, means CHANGE and requires a change in culture, training in Lean concepts is required for both management and the hourly workforce in order to produce an effect on a continuing basis.

Resistance to change, at least in manufacturing, is ingrained. Manufacturing has been taught through the years to do things in a repetitive fashion in order to achieve uniformity of quality and uniformity of product. This is a good philosophy if there is no competition. However, in today's global economy the competition is fierce. In addition, TimeWise demonstrates the value of implementing Lean concepts by preparing net income statements for each of the four rounds of simulation. Sales numbers are calculated for each of the three models of clocks.

Real Success Leads to Value-Add Activities

One of their clients is a manufacturer of a high volume item used in over 80% of all vehicles, including automotive, in the US. Their products are in danger of becoming commodities, and as such, the company is in danger of losing jobs to China. They have responded by training all of the almost 300 employees in the Lean 101 TimeWise Workshop. In parallel with the training, the company has undertaken an extensive lean implementation program. Among the many improvements in metrics, the company has freed up over 25% of their existing factory space.

The company plans to use the space for value-added activities for their customers. By moving up the value chain, the company will realize increases in both revenue and profits. But more importantly, the company will insure their long term viability as an ongoing business, and will not only retain jobs, but will increase the level of employment at the plant. Going Lean is a way to succeed and maintain profits and reduce costs.




