Chamber Supports Healthcare Training Grant

Joins BAWIB, Hospitals and Veterans

A grant application to provide up to five million dollars in health care training for veterans has won widespread support from throughout the region. The Metro South Chamber of Commerce is working closely with the Brockton Area Workforce Investment Board and many veterans organizations to secure funding. In addition, two of the three local hospitals along with many local colleges and universities have signed on as partners. The grant will provide training to veterans and other community members in the field of medical training (Laboratory Technician, EMT, Pharmaceutical Assistants and Phlebotomy). "This grant is another example of how this community comes together for the benefit of our veterans and displaced workers. We appreciate all those who found a way to say yes to this initiative," said Chamber President and CEO, Christopher Cooney. A site for the training has been identified near the Veterans Affairs (VA) Hospital.



Chamber Supports Gateway Cities Legislation



Chamber President and CEO, Christopher Cooney, recently travelled to the statehouse to testify before the House Finance Committee in favor of creating financial incentives for Gateway Cities like Brockton. Cooney joined Brockton 21, BBB and OCPC representatives along with Mayor James Harrington and Councilor Linda Balzotti in support of the legislation. Cooney submitted written testimony encouraging approval of legislation that would, "reward companies for locating in cities where ample public investment has already been made. Water, sewer, transportation, housing, healthcare and education facilities are all in place to attract skilled workers. This legislation is necessary to provide a return on the public investment we have already made in Gateway Cities." He went on to say, "This is both an urban and suburban agenda that has widespread support from all sectors that support sustainable development. Our Gateway Cities are green by design. Let's acknowledge the good that can come from public and private investments in our cities."

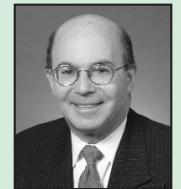

Dr. Donnelly Receives Fulbright Award

Brian Donnelly, Ph.D. has been awarded a Fulbright Scholar grant to lecture at Tartar State Humanitarian and Pedagogical University in Russia during the 2009-2010 academic year.

Donnelly will be working with education, university and college officials in Moscow and the Republic of Tartar to expand on the design of community colleges responsive to workforce education and adult learning needs for the Republic and for Russia.

Donnelly is one of approximately 1,100 U.S. faculty and professionals who will travel abroad through the Fulbright U.S. Scholar Program in 2009-2010. The Fulbright Program, America's flagship international educational exchange program, is sponsored by the United States Department of State, Bureau of Educational and Cultural Affairs.
