Charlie Baker has spent his career bringing success and strong management to both the private and public sectors in Massachusetts. Among the highlights of his career are helping to start the Pioneer Institute for Public Policy Research and working for the Weld/Cellucci Administration as Undersecre-

tary for Health in the Executive Office of Health and Human Services where he played pivotal roles in Medicaid reform, facility consolidation, and the expansion of a number of key public health programs. In addition, Baker served as Secretary of Health and Human Services where he worked to enact welfare Baker also served as Secretary of Administration and Finance where he re-structured the state's purchasing system, led a major effort to improve the state's capacity to collect third party rev-

enue, and oversaw the largest effort ever to modernize the state's code of regulation. In this position, he received the Distinguished Service Award from the National Governor's Association in 1998.

Following this, Baker became CEO of Harvard Vanguard Medical Associates (HVMA) and was soon recruited by Harvard Pilgrim Health Care to serve as its CEO. Baker led a major turnaround at HPHC, which included a \$220 million year-to-year improvement in financial performance from 1999 to 2000, and the amicable separation of HPHC and HVMA.


Also speaking will be Mr. Kim Hollon, new President and Chief Executive Officer of Signature Healthcare. Previously, Mr. Hollon served as Chief Operating Officer of Health System Pennsylvania where he oversaw four hospital campuses and a workforce of 4,500. During his tenure he made significant improvements in patient satisfaction, established a

physician liaison program to improve patient retention, and dramatically increased the number of Core Measure quality scores exceeding the state average.

UPDATE: Chamber Advocates Change to New 1099 Requirement

Metro South Chamber members travelled to Washington DC in May to meet with members of Congress to advocate for change to the proposed 1099 requirement that would dramatically increase the number of 1099s businesses would have to generate.

Chamber Chair -Elect, Peter Neville of Concord Foods and Christine Karavites, Chamber Chair of Government Affairs provided Senator Scott Brown with examples of how burdensome the new regulations would be to business.

The new regulations are based on twenty year old spending thresholds of \$600. per entity. Recently, Congress has drafted two new revisions and repeal language. It is very likely the legislation will be changed as the new language is scheduled to be voted within the next two weeks. Advocacy has made a major difference in this case. As a result, business will be spared the burden of this costly proposed change to the 1099 reporting system.

Brockton-Plymouth Receive HUD Housing Grants

Brockton-Plymouth receive \$636,000 in HUD housing grants for homeless. HUD recently awarded \$250,160 to the Brockton-Plymouth area for 2 new housing projects for homeless people through the Continuum of Care Homeless Assistance Program. Old Colony Y will provide housing and supportive services for 5 families, and Father Bill's and MainSpring for 3 chronically homeless individuals. This award follows HUD renewal funding of \$385,953 for permanent supportive housing for 32 formerly homeless households provided by Brockton Housing Authority, Father Bill's and MainSpring and South Shore Housing Development Corporation. United Way of Greater Plymouth County assists community providers to apply for these funds annually, and is about to assist them with the 2010 application for renewal and new funds.







SEED Loans Totaling \$1.3 Million to Brockton Area

Stop N Gas received a loan

Shuffain Insurance Agency received a loan of \$35,000 under the Micro Loan Program for furniture, equipment and to refinance credit card debt.

Under the SBA 504 Program, SEED can provide up to 40% of the financing needed behind a bank for the purchase of buildings and equipment. SEED's portion can range from \$80,000 to \$2 million for most small businesses, and \$4 million for manufacturing businesses, at a fixed interest rate below market for 20 years, currently 5.5%.

SEED can also lend up to \$200,00 for working capital and other uses. The term on the loans is up to 10 years with longer repayment periods, if necessary. Interest rates range from 5% to 6% fixed depending on whether there is bank participation.




